

Entry conditions

These entry conditions (hereinafter the "**Conditions**") govern your entry in our competition "1000 free nights" (the "**Competition**"). By entering the Competition, you confirm your understanding of - and your agreement to be bound by the - Conditions. If you do not accept the Conditions, please simply refrain from entering the Competition. The Conditions may be summarized (or reproduced in part) on our website or on our various advertising platforms (social media, e-mail, online advertisements etc.). Where appropriate, this information will be provided for information purposes only, and only the terms of the Conditions shall be valid.

In these Conditions, the terms "we" and "our" refer to the Geneva Tourism & Conventions Foundation whose registered office is in Geneva (the "**FGT&C**"). The terms "you" and "your" refer to the people entering the Competition.

Eligibility

The Competition is only open to entrants (individuals) who (i) are considered to be adults according to Swiss law (18 years and over), (ii) who are not resident in Greater Geneva (as defined [here](#)) and (iii) who are not employed by FGT&C or by a partner company of FGT&C in the context of the Competition. FGT&C - and its hotel partners - may require participants to provide proof of their eligibility at any time.

Free entry

Subject to compliance with the Conditions, entry is free. There is no obligation to purchase.

Entry form

To enter the Competition, please complete the form available on our website. In so doing, you guarantee that the details you provide are accurate and up-to-date. In particular, you guarantee that the address you provide is the address where you are officially resident.

Prize

The Competition gives participants the opportunity to win a night (i.e. a room) for two people at a selection of Geneva hotel establishments (breakfast and taxes included) (the "**Prize**"). Approximately 1000 nights will be offered by FGT&C in total.

Each entrant can only win one Prize.

Winners will be selected by FGT&C. They will receive an e-mail from FGT&C inviting them to book their night using a single use code to be used on our [online reservation system](#). Winners may choose their establishment from among a selection of 3, 4 or 5 star hotels, up to the limit of rooms still available at the time of booking (on a first-come, first-served basis). Bookings must be made no later than 31 May 2016. Bookings must be made for stays between 11 July and 12 September 2016.

FGT&C reserves the right to make the one-night booking subject to an agreement to pay a penalty in the event of a cancellation or no-show.

The Prize does not include any additional product or expense, particularly no transport ticket to Geneva (subject to any additional prize that the participant may win as part of the "Share and win your flight" campaign described in the paragraph below). FGT&C does not offer any guarantee linked to the Prize. Responsibility for obtaining the necessary authorisations and visas to enter and stay in Switzerland rests entirely with the winners (as winning the Prize does not bestow any right in this regard).

Winners are prohibited from selling the Prize or marketing it in any other manner. The Prize cannot be exchanged or refunded in return for cash.

Where necessary, FGT&C reserves the right to replace the Prize with a similar prize. If, for any reason, a potential winner cannot be contacted or refuses the Prize, FGT&C may re-enter the Prize into the competition. Winners accept that their name and country of residence will be published on our website or on our social media pages.

Share and win your flight

In addition to the Prize, entrants who share news of their entry in the Competition on social media can win one of the return flights (between their country of residence and Geneva) offered by our partner: Swiss International Air Lines.

For US participants: Prize must be accepted as awarded with no substitution. Prize is non-transferable and cannot be redeemed for cash or credit, in whole or in part. Fees, taxes and airport charges are responsibility of the winner. Winner and travel companion must travel together on same itinerary and is based on space availability at time of booking. Tickets and travel are valid on Swiss International Air Lines operated flights only. No frequent flyer mileage may be accrued

Flight winners will be selected by FGT&C from among those sharing news of their entry using the hashtag: **#InvitedByGeneva**.

With regard to the transport itself, the general conditions of Swiss International Air Lines shall apply.

Opting-In

Entrants accept that the personal data they provide in the context of the Competition (including their e-mail address) shall be used by FGT&C to provide them with marketing offers. Where appropriate, communications will contain a link allowing participants who no longer wish to receive these messages to unsubscribe at any time.

Change - Decisions - Liability

FGT&C reserves the right to change or cancel the Competition (and consequently require the return of Prizes) at any time, particularly in the event of unexpected circumstances, without notice and without having to state the reasons. FGT&C also reserves the right to cancel an entry or refuse a winner, also without notice and without having to state the reasons, in the event of fraudulent or unfair conduct aimed at distorting the result of the Competition or suspicion of such conduct.

MORE GENERALLY, ANY DECISIONS TAKEN BY FGT&C IN THE CONTEXT OF THE COMPETITION ARE DEFINITIVE AND BINDING UPON PARTICIPANTS. THEY CANNOT BE THE SUBJECT OF ANY DISCUSSION OR APPEAL. NO CORRESPONDENCE SHALL BE EXCHANGED WITH REGARD TO SUCH DECISIONS. FGT&C DOES NOT NEED TO JUSTIFY ITS DECISIONS.

YOU HEREBY UNDERTAKE TO INDEMNIFY FGT&C, ITS BODIES, AUXILIARIES AND REPRESENTATIVES FOR ANY DAMAGE THAT MAY RESULT FROM A VIOLATION OF THE CONDITIONS, IN PARTICULAR THE GUARANTEES GRANTED BY YOU IN ARTICLE 3.
